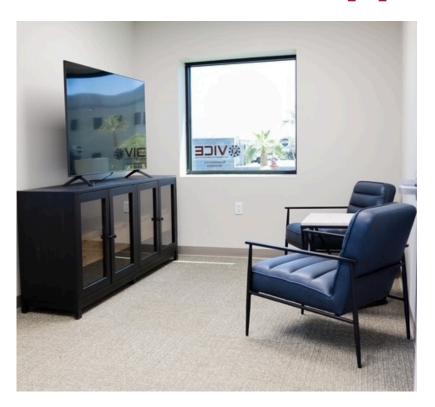
Customer Base
